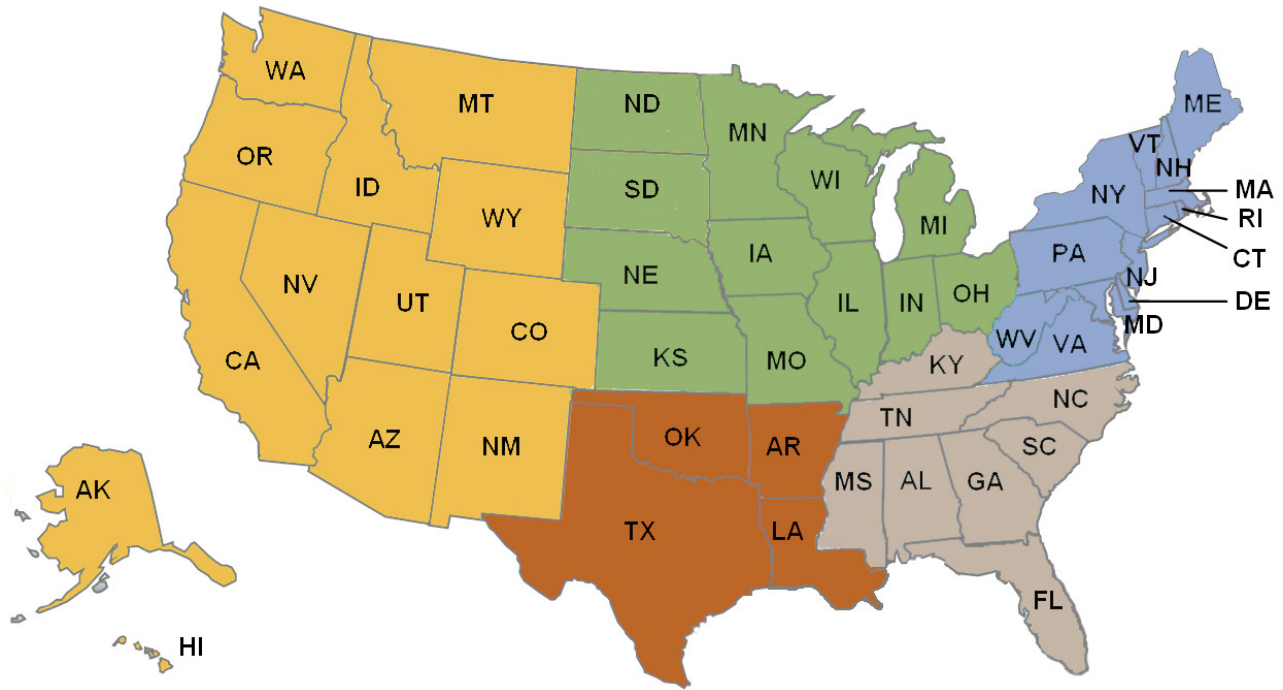


# GfG Instrumentation Sales Territory Map
